

ORDINANCE NO. 2019-01

AN ORDINANCE OF BETHEL TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, AMENDING BETHEL TOWNSHIP TRAFFIC AND PARKING ORDINANCE, ORDINANCE NO. 2008-07, AS AMENDED, BY RESTRICTING PARKING ALONG BOTH SIDES OF CHESTNUT STREET FROM ROSE ALLEY TO T686 SEYMOUR DRIVE

WHEREAS on October 28, 2008, the Board of Supervisors (“Supervisors”) of Bethel Township, (“Township”) adopted Ordinance No. 2008-07, the Bethel Township Traffic and Parking Ordinance (“Ordinance”); and

WHEREAS on December 18, 2012, the Supervisors adopted Ordinance 2012-06 amending the Ordinance by prohibiting parking along Fort Motel Drive, Court Street, and Airport Road; and,

WHEREAS on March 17, 2014, the Supervisors adopted Ordinance 2014-01 further amending the traffic ordinance; and,

WHEREAS since the adoption of the last amendment to the Ordinance, the Township engineer has recommended additional changes as described below.

NOW, THEREFORE, the Board of Supervisors of Bethel Township, Berks County, Pennsylvania, in lawful session duly convened, hereby ENACTS and ORDAINS as follows:

Section 1. Parking Amendments

Article IV - Parking - Section 2 - Parking Prohibited at all Times Certain Locations of the Ordinance is hereby amended by adding the following no parking provision:

Parking shall be prohibited at all times on the following street and location:

<u>Street</u>	<u>Side</u>	<u>Location</u>
Chestnut Street	Both	From Rose Alley to T686 Seymour Drive

Section 2. Construction, Application and Repealer.

This Ordinance amends Ordinance No. 2008-07, as amended by Ordinances 2012-06 and 2014-01, and is intended to be construed as a continuation as modified herein of the Bethel Township Traffic and Parking Ordinance. To the extent of any conflict, however, the provisions of this Ordinance supersede and control and any inconsistent provisions of all prior ordinances and all prior ordinances are hereby repealed in so far as, but only in so far as they are inconsistent with the terms and provisions of this Ordinance.

Section 3. Severability.


If any sentence, clause, section or part of this Ordinance for any reason is found to be unconstitutional, invalid, or illegal, such sentence, clause, section or part of this Ordinance shall not effect or impair the remaining provisions, sentences, clauses, sections or parts of this Ordinance which shall remain valid and in full force and effect. In such event, it is the intent of the Supervisors that the Ordinance would have been adopted had such unconstitutional, invalid or illegal sentence, clause, section or part not been included herein.

Section 4. Effective Date.

This Ordinance shall take effect within 5 days of enactment.


