**ORDINANCE NO. 2025-02**

**AN ORDINANCE OF BETHEL TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, AMENDING THE BETHEL TOWNSHIP TRAFFIC AND PARKING ORDINANCE, ORDINANCE NO. 2008-07, AS AMENDED, TO ESTABLISH ADDITIONAL STOP INTERSECTIONS**

**WHEREAS**, the Board of Supervisors of Bethel Township enacted Ordinance Number 2008-07 on October 28, 2008, known as the Bethel Township Traffic and Parking Ordinance, which established regulations for traffic and parking within the Township; and

**WHEREAS**, the Board of Supervisors amended Ordinance No. 2008-07 by adopting Ordinance Nos. 2012-06, 2014-01, 2019-01, and 2020-05; and

**WHEREAS**, Ordinance No. 2008-07, as amended, established stop intersections within the Township; and

**WHEREAS**, the Board of Supervisors desires to further amend Ordinance Number 2008-07 to establish additional stop intersections.

**NOW, THEREFORE BE IT ENACTED AND ORDAINED** by the Board of Supervisors of Bethel Township, Berks County, Pennsylvania, that the following be and is hereby enacted:

Section 1. Ordinance Number 2008-07, as amended, Article II entitled "Traffic Regulations", Section 2 entitled "Stop Intersections Established" is hereby amended to add the following to the list of stop intersections:

Section 2. Any ordinance or resolution or part of ordinances or resolutions conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.

Section 3. If any article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase or word in this Ordinance, is, for any reason declared to be illegal, unconstitutional or invalid, by any Court of competent jurisdiction, this decision shall not affect or impair the validity of the Ordinance as a whole, or any other article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase, word, or remaining portion of the within Ordinance. The Board of Supervisors of Bethel Township, Berks County, Pennsylvania, hereby declares that it would have adopted the within Ordinance and each article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase and word thereof, irrespective of the limitations, restrictions, sentences, clauses, phrases, or word that may be declared illegal, unconstitutional or invalid.

Section 4. This Ordinance shall become effective in accordance with applicable law.
